Travel dates: 20th to 24th July 2017

Departure: Dubai to Belgium 20th of July

Arrival: Belgium to Dubai 24th of July

- a. ALL PARTICIPANTS NEED TO BE ABOVE THE AGE OF 21 TO QUALIFY TO BE PART OF THE TOMORROWLAND BELGIUM PROMOTION.
- b. ALL PARTICIPANTS NEED TO BE RESIDENT OF UAE AND HOLD A VALID 3 MONTHS RESIDENCY VISA FROM THE DATE OF DEPARTURE- JULY 20TH 2017
- c. ALL PARTICIPANTS NEED TO HAVE A PASSPORT VALID FOR MORE THAN 6 MONTHS FROM THE DATE OF DEPARTURE (JULY 20TH 2017).
- d. ALL PARTICIPANTS WILL NEED TO BE AVAILABLE TO TRAVEL TO BELGIUM BETWEEN 20-24TH JULY 2017
- e. THE PRIZE IS NEITHER TRANSFERABLE NOR REFUNDABLE. IF FOR ANY REASON THE SELECTED WINNER OR COMPANION CANNOT BE PART OF THIS TRIP THE TICKET WILL BE FORFEITED AND SHOCK MIDDLE EAST WILL AWARD THE

PRIZE TO ANOTHER WINNER.

- f. SHOCK MIDDLE EAST WILL NOT BE RESPONSIBLE FOR PROVIDING LISTNERS WITH ANY TRAVEL DOCUMENTATIONS INCLUDING BUT NOT LIMITED TO VISA'S, SCHENGAN VISA, PASPORTS OR ANY REQUIRED TRAVEL DOCUMENTATION NEEDED TO TRAVEL TO BELGIUM.

- i. SHOCK MIDDLE EAST WILL NOT BE RESPOSIBLE FOR ANY FEES INCURRED WHEN PROCESSING ANY VISA OR DOCUMENATTION, THIS INCLUDES BUT IS NOT LIMITED TO VISA APPLICATION, COURIER SERVICES, PHOTOGRAPHY SERVICE, PREMIUM SERVICE, PRIME TIME APPOINTMENT AND PRIORITY VISA SERVICE. IN CASE THE VISA IS REJECTED SHOCK MIDDLE EAST WILL NOT BE RESPONSIBLE FOR ANY MONATORY REIMBURSEMENTS.
- j. SHOCK MIDDLE EAST SHALL NOT BE RESPONSIBLE FOR THE GUARANTEE OF A VISA OR TIME TAKEN TO PROCESS THE APPLICATION.

- k. IF THE PARTICIPANTS DO NOT RECEIVE THE REQUIRED VISA/ DOCUMENTATION BEFORE JULY 13TH 2017, THEY SHALL NOT BE ELIGIBLE TO TRAVEL AND THE PRIZE SHALL BE FORFEITED AND AWARDED TO ANOTHER LISTENER.
- l. SHOCK MIDDLE EAST SHALL PROVIDE BASIC TRAVEL INSURANCE FOR EACH PARTICIPANT, THE DETAILS OF THE TRAVEL INSURANCE WILL BE SHARED WITH EACH LISTENER.
